REAGENT PREPARATION

Washing Buffer (1×) Preparation


Pour entire contents (50 ml) of the Washing Buffer Concentrate (10x) into a clean 500 ml graduated cylinder. Bring to final volume of 500 ml with glass-distilled or deionized water. Transfer to a clean wash bottle and store at 2 to 25° C.

Standard Curve Preparation:

S1 to S6 and S0 is ready to use for serum and plasma.

Other sample type, prepare the standard curve with whatever buffer (SPB, Sample Prepared Buffer) is used to prepare the sample, such as cell culture supernatant, tissue grinding liquid, cell lysate, etc. Urine sample use AB (Assay Buffer) prepare standard curve.

The Mouse CXCL10 Standard EM0014S 200000 pg/ml 40 μ l + 360 μ l SPB serves as the high standard (20000 pg/ml). Pipette 200 μ l of SPB into each tube. Use the high standard to produce a 1:1 dilution series. Mix each tube thoroughly before the next transfer. SPB serves as the zero standard (0 pg/ml).



DA 1× Preparation:

Mix well prior to making dilutions.

Make a 1:100 dilution of the concentrated Detect Antibody solution with DD (Detect Antibody Diluent) in a clean plastic tube as needed according to the Standards and Samples.

ASSAY PROCEDURE

Bring all reagents and samples to room temperature before use.

 Prepare all reagents and working standards as directed in the previous sections.

Remove excess CP (Coated Plate) strips from the plate frame, return them to the foil pouch and reseal.

3 Add 50 μl of AB (Assay Buffer) to each well.

4 Add 10 µl of **Standard or sample** per well. Ensure reagent addition is uninterrupted and completed within 15 minutes.

5 Add 50 μ l of **DA 1**×(Detect Antibody) to each well.

($\stackrel{\bullet}{}$ Cover with an SF (Sealer Film). Incubate at room temperature (18 to 25°C) for 1 hour on a microplate shaker set at 500 rpm.

Aspirate each well and wash, repeating the process four times. Wash by filling each well with WB (Washing Buffer 300 μl). Complete removal of liquid at each step is essential to good performance. After the last wash, remove any remaining WB (Washing Buffer) by aspirating or decanting. Invert the plate and blot it against clean paper towels.

8 Add 100 μl of SH (Streptavidin-HRP) to each well.

Over with a new SF (Sealer Film). Incubate at room temperature (18 to 25°C) for 30 min on a microplate shaker set at 500 rpm.

10 Repeat aspiration/wash as in step 7.

(1) Add 100 μ l of TS (TMB Substrate) to each well. Incubate for 5-30 minutes at room temperature.


12 Add 100 μl of SS (Stop Solution) to each well.

B Determine the optical density within 30 minutes, using microplate reader set to 450 nm corrected with 570 nm or 630 nm.

SENSITIVITY

The minimum detectable dose (MDD) of mouse CXCL10 is typically less than 213.35 pg/ml.

The MDD was determined by adding two standard deviations to the mean optical density value of ten zero standard replicates and calculating the corresponding concentration.

PRECISION

Intra-assay Precision (Precision within an assay) Three samples of known concentration were tested twenty times on one plate to assess intra-assay precision.

RECOVERY

The spike recovery was evaluated by spiking 3 levels of mouse CXCL10 into health mouse serum sample. The un-spiked serum was used as blank in this experiment.

The recovery ranged from 86% to 114% with an overall mean recovery of 97%.

LINEARITY

To assess the linearity of the assay, five samples were spiked with high concentration of CXCL10 in mouse serum and diluted with Sample Diluent to produce samples with values within the dynamic range of the assay.

The linearity ranged from 89% to 110% with an overall mean recovery of 102%.

SAMPLE VALUES

Serum/Plasma – Thirty samples from apparently healthy mice were evaluated for the presence of CXCL10 in this assay. No medical histories were available for the donors.

n.d. = non-detectable. Samples measured below the sensitivity are considered to be non-detectable.
